

Conditions for publication in the journal Ecología Política

Articles for the section 'Reviews of books, reports or webpages'

DESCRIPTION

The articles in this section are reviews of publications connected with political ecology issues. We welcome review texts that connect a critique of recently published books about specific cases (e.g. environmental conflicts) with up-to-date information from associations or social movements that are involved in the same cases, as well as reviews of international reports and webpages about current debates. In case of reviews on theoretical publications, we recommend to explain the benefits of these works concerning social and environmental movements, and to connect them with other works, case studies, etc.

STRUCTURE AND MINIMUM CONTENT

The article must contain:

- Title of the article.
- *Keywords (3-5)*, in English and Spanish.
- Name of the author and his/her institution. This information will be published in the article.
- *Email of contact.* This information will be published in the article.
- Postal address and (if available) twitter and facebook account. This information will not be published in the articles. It is required for sending a hard copy of the journal to the author and for communication purposes.
- Tables and/or graphs (aside)
- *Photos related to the article* (aside, with the highest resolution possible)
 - The text has to indicate where to put the photos, graphs and tables; their subtitles and sources
 - The format for the subtitles of images to be placed below the image is the following:
 - Table 1. Xyxyxyxyxy zxzxzx zxzx (Source: Statistics of xyxyx)
 - Graph 1. Xyxyxyxyxy zxzxzx zxzx (Source: Own elaboration)
 - **View of the region xyxyxyx (Author: Joan Garcia** the person who took the picture -)
 - Other images, posters, illustrations: Image 1. Poster of the movement Xyxyxyxyxy zxzxzx zxzx (Source: Climate March, 2015)
- Bibliographical references
- Relevant websites where to find more info (at the end of the article).
- Keywords of the article (3-5 words)

LENGTH, FORMAT AND REFERENCES

The article should be max. 1,000 characters (without including spaces but including references) and approximately 2 pages long, in the following format:

- Font: Times New Roman, 11pt.
- Space between lines: 13 pt.
- Space between characters: Normal
- Alignation: Justified
- Margins: superior 2,6 cm, inferior 3 cm, left 2,5, right 2,5

References:

The references have to be revised according to the format of the journal:

- **Inside the text**, bibliography should be referenced with the name of the author and the publication date; for instance: (White, 1997). In case of quoting, it has to include page number, for instance: (White, 1967: 1205).
- At the end of the article, bibliography should be referenced as follows:

- They are used whenever the author wants to refer to websites for more information
- They are not used to give reference to journals or books
- Within the text they will be indicated through superscripts that are numbers: 1,2,3,4,....
- The footnote has to be written with this format: Times News Roman, 8pt.

INCLUSIVE LANGUAGE

Once English texts are translated into Spanish, we will try to ensure an inclusive language that reflects diversity. Therefore, we encourage authors to review their texts to ensure that language does not reproduce sexism. While writing, please try to indicate and visibilise when women, and /or other non-binary identities have a role in the environmental struggles or mobilisations you describe.

RIGHTS AND DUTIES OF AUTHORS

By sending the article the authors accept its possible publication in the semiannual journal Ecología Política. In case of publication, the article will be handed in to subscribers as a hard copy and/or in digital form according to their subscription. According to the journal's publication policies, the authors accept that their articles will be open access in the webpage of the journal, in Dialnet system or analogous portals after one year of their publication.

The authors are accountable to editors for the originality and authorship of their work and declare that all authors have approved the content of the submitted manuscript and that they have no conflict of interest with third persons. The journal ensures that the names of the authors appear in every platform of publication.
